

Troop Bank Account Authorization

Note to Bank:

Girl Scouts of South Carolina–Mountains to Midlands, Inc. (GSSC–MM) requires troops to maintain troop funds at a federally-insured financial institution for safety purposes as well as for teaching girls about financial management. We enlist your support in this endeavor. This is an opportunity for your financial institution to build future clients. Since GSSC–MM is a non-profit organization under section 501(c)(3) of the Internal Revenue Code, we sincerely hope that a service charge will not be imposed. GSSC–MM retains authority over the account only for authorized activities. If the bank suspects inappropriate or unauthorized account activity, if there are changes to the authorized signatures, or if the account remains dormant for six (6) months, please notify GSSC–MM at the Greenville address below.

Note to Troop and Bank about New Troop Accounts:

The bank account shall be opened in the name of Girl Scouts of South Carolina–Mountains to Midlands, Inc. Troop _____ (insert troop number). Each troop bank account must have at least two (2) signatures of non-related adults. One signature is required on checks for withdrawal of funds for troop accounts. The troop should not be paid interest on this account. GSSC–MM permits the issuance of debit cards for troop accounts. GSSC–MM does not authorize issuance of credit cards to any troop.

Girl Scouts of South Carolina–Mountains to Midlands, Inc. prohibits the use of its Federal Tax Identification Number, the Council Name, or any Council financial information to obtain a credit card, open any interest-bearing account, or secure any credit-based product for any and all troops.
